1. Applications are invited from unmarried eligible men & women candidates for grant of Short Service Commission (SSC) in under-mentioned branches / entries in the Indian Navy for course commencing Jan 21 at Indian Naval Academy (INA) Ezhimala, Kerala. Candidates must fulfill conditions of nationality as laid down by the Government of India.

(i) These vacancies are tentative and may be changed depending on availability of training slots.

(ii) * **Commercial Pilot License (CPL) Holders.** Candidates having valid and current CPL issued by DGCA (India) and born between **02 Jan 1996** and **01 Jan 2002** (both dates inclusive) can apply for Pilot entry as per eligibility criteria stated at Para 2(d) & 2(e).

(iii) ** **Merchant Navy Personnel.** Candidates having Government of India, Ministry of Shipping & Transport Certificate of Competency (Foreign going) either as a Second Mate, Mate or Master and born between 02 Jan 1991 and 01 Jul 2001 (both dates inclusive) can apply for Executive Branch entry (General Service) and Technical Branch entry (SSC Engineering) as per stipulations stated at Para 2(h) & 2(j) respectively.

3. **Who Can Apply.** Candidates who have graduated or in the final year of the applicable qualifying degree in the above mentioned disciplines from a AICTE recognised educational institute/AIU certified foreign university can apply for the exam. The candidates will, however, be required to fulfil the educational qualifications stipulated above before joining INA. The candidates failing to meet stipulated educational criteria will not be permitted to join INA, Ezhimala.

Note (3): - (i) Only one application can be filled by a candidate. (ii) Candidates will be shortlisted based on their INET(O) marks only. (iii) Candidates desirous of joining SSC Pilot, Pilot (Other than MR) and Observer are to select these branches as options 1 and 2 only, to be eligible for SSB call-up/CPSS/Aviation Medicals (iv) Upto Approximately 750 candidates, who have chosen SSC Pilot or Observer entries, will be considered for SSB/CPSS/Aviation Medical Examinations, based on marks scored in INET(O). Remaining candidates will be considered for other entries chosen by them. (v) **Candidates must indicate their preference for other branches/cadres also, if they wish to be considered for those branches/cadres. Candidates will not be considered for branches/cadres that they have not selected. Candidates are advised to ascertain their eligibility for branches/cadres, with respect to applicable medical standards, prior to indicating their preference.** (vi) Candidate will be allocated branches/cadres based on their merit and preference, subject to fulfilling other criteria such as education, medical standards etc. (vii) No equivalent stream of BE/ B.Tech /other qualifications other than those mentioned in para 2 above will be considered valid for selection process at any stage.

4. **Medical Standards/ Relaxation in Height and Weight, Tattoo, Pay & Allowances/ Group Insurance & Gratuity/Leave Entitlements/Tenure of Commission/ Duties of Officers.** Please visit website www.joinindiannavy.gov.in for information.

5. **Selection Procedure** The selection procedure is as follows:-

(a) INET(Officer).

(i) **Examination Centre.** All candidates, whose applications are received by due date, will be called for INET(O) to be conducted tentatively in Feb 20 at the designated INET(O) centres. Call up letters cum Admit Card for online examination indicating date, time and place, which is scheduled during Feb 2020, would be required to be downloaded from the official website www.joinindiannavy.gov.in tentatively by last week of Jan 20. Only Electronic mode of communication will be used while contacting the candidates at all stages of selection.

(ii) **INET(O) Syllabus.** INET(O) will be of two hours duration. It will contain 100 Multiple Choice Questions comprising Questions on English, Reasoning & Numerical Ability, General Science, Mathematical Aptitude & General Knowledge. Each section will be of 100 marks with negative marking of one mark for incorrect answer.

(b) **Shortlisting for SSB.** IHQ MoD (N) reserves the right to shortlist upto approximately 8000 candidates for SSB, strictly on the basis of INET(O) rank and choice of preference of entries mentioned by the candidate in the application. Candidates are required to qualify in all sections of INET(O) to be considered for shortlisting to appear in SSB interview. No communication will be entertained in this regard. SSB interviews for short-listed candidates will be tentatively scheduled from **Apr 20** at Bangalore / Bhopal / Visakhapatnam / Kolkata.

Shortlisted candidates will be informed about their selection for SSB interview through e-mail or SMS (provided by candidates in their application form). Candidates are **advised not to change their e-mail/mobile number** till selection process is over.

(c) **SSB Procedure.** Details of SSB procedure are available on Indian Navy website www.joinindiannavy.gov.in

(d) **Medical.** SSB recommended candidates are required to undergo medical examination as applicable to their entry. Candidates of Pilot entry are required to undergo Computerised Pilot Selection System (CPSS) followed by Aviation medical examination. Candidates for Observer entry are to undergo Aviation medical examination.

(e) Merit List & Appointment Letter.

(i) **Merit list of all candidates will be based on combined marks of INET(O) & SSB,** and the entry for which the candidate has undergone SSB interview and medical examination. No change of entry will be permitted/ entertained after allocation of entry for SSB interview.

(ii) Candidates recommended by the SSB and declared medically fit will be appointed for training as per all India merit of each branch / cadre based on availability of number of vacancies in various branches / cadres.

(f) **Examination Fees** Candidates (SC/ST/women candidates are exempted from payment of fees) are required to pay a fee of Rs 215/- (Rupees Two Hundred fifteen only) through online mode. Admit card will be issued for the examination only to those candidates who have successfully paid the examination fee and who are entitled for waiver of examination fee.

Note (4) (i) Fee once paid shall not be refunded under any circumstances nor can the fee be held in reserve for any other examination or selection. (ii) There is no reservation of vacancies for the candidates from SC/ST category. Candidates from SC/ST category are entitled to waiver of examination fee only. (iii) In case online payment of fees has been done and money deducted without application number being generated (i.e. unsuccessful payment), please wait for 07 working days for automatic refund of money to your account.

(g) Change of INET(O) / SSB Centre for examination / interview is not permissible under any circumstance.

(h) Any correspondence regarding change of SSB dates be addressed to the call up officer of the concerned SSB on receipt of call up letter. Candidates are to download the call up letter on receiving intimation from IHQ MoD (N) at SMS/email (provided by candidate in their application).

(j) No compensation is admissible in case of any injury sustained as a result of tests during SSB interviews.

(k) AC 3 tier rail fare is admissible for the SSB interview, if appearing for the first time for particular type of commission. Candidates are required to bring photocopy of the first page of pass book or cheque leaf where the name, A/C No. & IFSC details are mentioned, while appearing for SSB.

Training

6. Candidates except Merchant Navy will be inducted in the rank of Sub Lieutenant. Merchant Navy candidates having Government of India, Ministry of Shipping & Transport Certificate of Competency (Foreign going) either as a Second Mate, Mate or Master will be inducted as Acting Lieutenant. Officers of all branches / cadres except the officers of IT will undergo 22 Weeks Naval Orientation Course whereas officers of SSC (IT) will undergo 04 Weeks Naval orientation Course at the Naval Academy, Ezhimala. This will be followed by professional training in Naval Ships and Training Establishments as per extant regulations.

Note (5)

(a) Probation period for SSC (NAIC) Officers is three years and for officers of other branches/cadres is two years. The probation period will commence from the date of grant of the rank of Sub Lt and will terminate after three years in respect of SSC (NAIC) and two years for other branches / cadres or on completion of initial training (whichever is later) during probation the officers are liable to be discharged in case of unsatisfactory performance at any stage.

(b) Only unmarried candidates are eligible for training. Any candidate who is found to be married or marries while under training will be discharged from service and shall be liable to refund full pay & allowances drawn by him/her and other expenditure incurred on the candidate by the Government.

(c) If the officer voluntarily withdraws from initial training or resigns during the probationary period, he/she shall be required to refund the cost of training in whole or in part, as may be determined by Govt. & all money received by him/her as pay & allowances from the Govt. together with the interest on the said money calculated at the rate in force at the time of loans.

(d) Candidates who fail to qualify the flying training (Pilot/Observers) will not be retained in Service.

How to Apply

7. Candidates are to register and fill application on Indian Navy website www.joinindiannavy.gov.in. To save time during the application submission window, candidates can fill in their details and upload documents in advance.

8. **Online (e-application).** Whilst filling up the e-application, it is advisable to keep the relevant documents readily available to enable the following:-

(a) Correct filling up of personal particulars. Details are to be filled up as given in the Matriculation Certificate.

(b) Fields such as e-mail address, mobile number are mandatory fields and need to be filled.

(c) All relevant documents (preferably in original), marks sheets upto 5th & 7th semester for regular and integrated B.E. / B.Tech courses & other degree examination respectively, date of birth proof (as per 10th & 12th certificate), CGPA conversion formula for BE/B.Tech, Commercial Pilot Licence (CPL) issued by DGCA, Government of India, and a recent passport size colour photograph should be scanned in original JPG/TIFF format, for attaching the same while filling up the application.

(d) If any scanned document is not legible/readable for any reason the application will be rejected. Candidates are to take print out of application and carry it while appearing for INET(O) or SSB interview.
